

Sedan facility improvements included a 60,000 bushel pe hour bulk weigher system which increased the speed of loading a train by 6-8 hours per train.





AURORA

The Aurora seed shed investment will allow for further expansion into new areas and improve timeliness in delivery to our dealer network and create efficiencies by combining seed assets from multiple locations into two larger hubs. This will enhance local customer experience for the owners who will be able to utilize th facility.



The equipment installed in the shed has increased the speed of unloading and loading product four times faster than before.

The new shed has also been set up to unload both trucks and rail cars, and has the capability to treat fertilizer prior to going into the bins. The upgrades to the facility have improved our efficiency significantly. This made the process much safer, ensuring our employees are in the best possible working evironment.

Aurora Cooperative had significant growth in the Prairie Valley seed line due to the excellent performance with on-farm yield. This growth has allowed us to secure two fully operational seed storage and treatment facilities in Kearney and Aurora, Nebraska. These investments will allow for further expansion and growth into new areas as well as improve timeliness in delivery and service to our dealer network. The new facilities will create more efficiencies by combining seed assets from multiple locations into two larger hubs, as well as enhancing the experience for the local customer.

Another capitol improvement project completed in 2022 was the installation of a hot water heating system at the Paddock location. The addition of the hot water heating system will enable us to be able to produce a higher quality product in less time.

On the fuel side of the business, we added bulk ethanol tanks and plumbing to six of our bulk fuel sites. With the installation of the new tanks, we have the capability to blend different quantities of ethanol for deliveries to our growers. During this process we doubled the size of the bulk plant at the Bertrand location in turn creating greater efficiency at the location.

The joint venture plans to make significant investments with the goal of increasing production and efficiency at the ethanol facilities so that the facilities remain a destination for area farmers' corn for many years to come.

Aurora Cooperative's Board Chair, Bill Schuster, said "We are looking forward to a partnership with KAAPA Ethanol at our ethanol and grain facilities. KAAPA has a track record of operational expertise and strong financial performance. We believe this partnership will strengthen the future of the ethanol plant for our farmer-owners."

KAAPA's Board Chair, Paul Kenney, said "Aurora Cooperative has led the way in promoting E-15 and higher ethanol blend fuels in Nebraska with its A-Stops and other efforts. We are pleased to have the opportunity to partner with Aurora Cooperative with its ethanol and grain facilities west of Aurora and look forward to a long and prosperous partnership."

Chris Decker, Aurora Cooperative's Chief Executive Officer, said "I'm excited to partner with KAAPA, they are a successful Nebraska-based company. Like Aurora Cooperative, KAAPA is owned by farmers. Aurora Cooperative and KAAPA share similar values and exist for the sole purpose of serving our farmer-owners. Aurora Cooperative believes this partnership will allow us to make the investments needed in order for these assets to remain a value-added destination market for our farmer-owners in the future."

Chuck Woodside, KAAPA's Chief Executive Officer, said, "We are excited for the opportunity to partner with Aurora Cooperative at its ethanol facilities west of Aurora. Hamilton County is an excellent location logistically for an ethanol plant. The proximity to our plants in Minden and Ravenna will give us the opportunity for additional synergies."

Aurora Cooperative and KAAPA anticipate the transaction will close in early 2023, subject to customary closing conditions, and look forward to a bright future serving Hamilton County and surrounding area farmers.

We had the opportunity to help over 170 show kids improve their showmanship skills and their overall animal knowledge. All day clinics were held in York, Franklin, St. Paul and Belleville, KS. With the overwhelming attendance and positive feedback from attendees, the Animal Nutrition team is looking forward to hosting more show clinics at different locations in 2023.



DONATIONS

In 2022 we exceeded over \$300,000 worth of local community donations. Supporting our schools, chambers, church activities, sporting teams, community groups, FFA Chapters and more. In addition, we were able to participate in many educational agriculture events to help further develop our upcoming youth and those wanting to pursue a future in agriculture. We were able to give back to over 50 communities throughout the Midwest and within our trade territory.



In 2022 Aurora Cooperative infused **\$51,000** into our local communities by partnering with Land O'Lakes, CHS and CoBank through a matching grant program, thus doubling the impact of our giving to hometown projects. Dollars given through the matching grant program went to a variety of projects that focused on education, hunger relief and community vitality, including early childhood education centers, development of agriculture learning labs and Title I reading and math programs in school districts, community garden projects, and renovations and repairs to buildings vital to the survival of our communities. Aurora Cooperative is thankful for the opportunity to collaborate with Land O'Lakes, CHS and CoBank to support and strengthen our communities. We are looking forward to aiding more communities in 2023!

DIVISION HIGHLIGHTS.

AGRONOMY.

Challenge & Success

As I look back on Aurora Agronomy's 2022 season, it proved to be another year full of successes and challenges. Our employees and customers worked together to overcome weather-related challenges with much of our trade territory, being affected by wind, hail, and this year's specialty, widespread drought throughout most of Nebraska. The numerous weather-related challenges coupled with ongoing supply chain issues and nationwide labor shortages caused plenty of reasons for concern. However, our employee group, working side-by-side with our growers, proved to make an extremely daunting job look easy. I am very proud of our group of employees and how they stepped up in the face of adversity and found solutions to these challenges.

In 2022 we continued to invest capital into projects that will continue to improve efficiencies, not only for our employees, but for our growers as well. For instance, after an electrical fire at our Buda facility in Kearney, we were able to replace our 1,600 ton shed with a much more efficient 5,000 ton shed. This improvement made the facility capable of extremely quick unload times not only by truck, but by rail as well. This upgrade has also allowed us to add a state-of-the-art fertilizer impregnation unit to treat product upon arrival, along with significantly cutting down on wait times on outbound shipments. In addition, we have added a hot blending system to our Central City facility, allowing us to make high quality custom blends at our customers request in a fraction of the time. We have also upgraded our blending system at our Mitchell, South Dakota location allowing for faster blend times. We finished off the year adding 20 side by side anhydrous trailers between our Aurora and Fairbury locations, allowing for safer delivery by our employees and longer run times for our growers applying ammonia.

Finally, as Aurora Agronomy moves into 2023 we will continue to further our team's

agronomic knowledge by testing the newest products on the market through Real Farm Research and Owners Acres research engines. From the information gained through our research, we will provide growers with new and innovative ways to produce the best crops as economically as possible.

The Agronomy Division remains committed to bringing a digital footprint to our growers. Utilizing systems like Field Alytics and Aurora's digital platform, allows growers to see and analyze their farm's information, making it simple to connect all your farm's equipment and application data and turning it into usable information. We also continue to improve our mobile app, creating a unique experience by giving you the ability to see all your fields, grain tickets, sign fertilizer contracts, and approve all your application work orders in one spot. We strongly encourage all customers to please ask their Aurora representative about accessing and utilizing the Aurora Cooperative Digital App.

As it is with everything, 2022 was rewarding and challenging for both our growers and the Aurora Agronomy Division. We sincerely hope that all of you and your families have a safe and blessed 2023 growing season!

We lost two grain bins at Clay Center due to the windstorm in May. We ramped up our outbound shipments during harvest to be sure we were able to keep space for your grain and are currently working on what our best plans would be to replace and improve operations there. Additionally, we had the explosion at Sedan in June. Thankfully nobody was hurt. Heavy shipment in early harvest was also necessary to keep available space for you. We have been able to replace and improve on the equipment in Sedan. We had hoped to have all the bugs worked out by Harvest but unfortunately it took longer than we had hoped. Thank you very much for your patience as we work through this unfortunate incident.

I am new to Aurora Cooperative having started October 1st, but I can say I am really excited about being here. My focus will be to move our Grain Division forward, focus on future growth and improvements, and having the right folks in the right place to accomplish this.

2022 was a year of unknown happenings, whether it was the markets, the weather, or the global climate. The one thing our Animal Nutrition Team

This past year the Energy Division celebrated many accomplishments, making this year one of the busiest and most successful years we have seen. However, we have also endured a few challenges. The labor market and supply chain shortages with equipment and goods, not to mention the very dry weather pattern, made for an interesting year. Nevertheless, our staff performed at a very high level and stepped up to the challenge. We are prepared to embrace new obstacles, and are excited about the new additions we will see in 2023.

As we looked for ways to be more innovative, the Energy Division was forced to adopt practices to become more efficient. We aggressively stepped up our implementation of tank monitoring technology to help increase efficiency for our employees and supply for our patrons. We have upgraded six of our bulk fuel sites with ethanol tanks and blending equipment to be more effective in providing customers with ethanol blended fuel choices delivered to their tanks throughout our trade

territory. These changes are exciting, and we will continue to look for more ways to improve our efficiencies.

The Energy Division is currently in the process of expanding retail fueling sites by adding A-stop locations and growing services such as on-farm tire service in strategic locations throughout the Aurora Cooeprative footprint. We will continue to upgrade equipment and rolling stock to keep up with growth and customer's needs.

We have enjoyed growing in 2022 and are excited to see what the future holds.

Growing without limits is what we do and because we have stayed focused on this promise we have been able to grow exponentially since inception in 2019.


For three straight years, we have doubled growth of Prairie Valley seed which currently has us over one point of market share in both corn and soybeans. We integrated Enlist and XTendFlex soybean portfolios into the Prairie Valley Brand to provide growers with solutions they need. Prairie Valley has access to multiple genetic and trait suppliers allowing us to continue to offer elite seed genetics which have been locally selected and tested to optimize each acre in our region.

In 2022, we significantly expanded our dealer network outside of Aurora Cooperative retail to allow other areas in Nebraska to experience the Prairie Valley way. We continue to conduct our own research in combination with our genetics suppliers to pick the products that are built for our areas - "the seeds for where you are". Expanded testing at Real Farm Research and Owners Acres continues to test products using the farm management practices that are relevant to your geographies.

As we look to the future, we are building a brand that will stand the test of time. We are investing not only in our product portfolio but also in our distribution network, our people and most importantly, technology enabled agronomic research, that will continue to keep us on the forefront of the seed business. 
