### Cardtrol Agreement

This agreement, made and entered into by and between the undersigned, hereinafter referred to as "Customer" and Aurora Cooperative Elevator Company, hereinafter referred to as "ACEC".

Fuel card(s) may be used to operate the fuel pumps at ACEC's locations.

- Customer agrees to comply with the credit policy of ACEC, which states all purchases included on each monthly statement are due and payable in full on or before the 25th day of the month following the date of statement. It is understood if the customer fails to abide by the credit policy, ACEC may cause the Customer's Cardtrol card to be invalid.
- In addition to any other purchases, Customer agrees to promptly pay ACEC for all gallons delivered through the Cardtrol system and recorded on the Customer's statement. **In the event of a lost or stolen card, Customer agrees to immediately notify ACEC, which will then promptly render that particular card invalid.** Until such date and hour as Customer has so notified ACEC of a lost, stolen, or misplaced card, Customer shall remain liable for all Cardtrol purchases recorded on Customer's statement. Upon notification of the loss or disappearance of any card, ACEC agrees to change the card number and issue the customer a new card.
- Customer agrees to not leave the dispensing equipment unattended at any time while it is being operated and to accept the responsibility of controlling sources of ignition. The Customer agrees to abide by all state fire regulations and also Environmental Protection Agency rulings while utilizing the Cardtrol system.
- Customer may terminate this agreement at any time by returning all the cards to ACEC along with payment in full for petroleum purchased.

#### PIN NUMBER (Personal Identification Number)

- Your Personal Identification Number (PIN) is a special 4-digit number which must be manually entered at the Cardtrol reader every time you purchase fuel. A PIN is used for security. Please store your PIN separately from your Fuel Card.
- Your PIN will be assigned by ACEC.
